Categories for the Description of Works of Art (CDWA)

A metadata schema that describes a set of categories and recommendations that may be used to design information systems and to catalogue art, architecture, and related materials, including archaeological and archival materials.

Getty Thesaurus of Geographic Names (TGN)

A structured vocabulary that contains names and other information about geographic places; it is focused on, but not limited to, places important to art, architecture, and related disciplines. Updated monthly.

A set of rules for the descriptive cataloguing of prints, photographs, and other graphic materials. Does not include rules for subject cataloguing and classification. Compatible with the second edition of the Anglo-American Cataloguing Rules (AACR2), which is widely used in libraries for the descriptive cataloguing of books and other materials.

Available as a computer file or in microfiche through the Library of Congress; also made available in electronic form by various vendors. When made available separately, it is sometimes called Library of Congress Name Authority File (LCNAF); when made available in conjunction with Library of Congress Subject Headings (LCSH), it is sometimes called Library of Congress Authority File (LCAF).

A structured vocabulary designed to represent the subject and form of the books, serials, and other materials in the Library of Congress collections, with the purpose of providing subject access points to the bibliographic records contained in the Library of Congress catalogues. More broadly, LCSH is used as a tool for subject indexing of library catalogues and other materials (including visual materials). Available in print (annual) and microfiche (updated quarterly). Also available on line from various vendors and bibliographic utilities, and as part of the Library of Congress CD-ROM product *Classification Plus*.
